With no further nominations from the floor, the Directors and office bearers were duly elected.

6. **General Business** – open to the floor for members to submit matters for discussion.

Impacts of D&BP

- Bruce Asked how others were finding the registration process under the new regime particularly for those whose degrees pre-date the Washington Accord.
- General discussion of recognition of qualifications from overseas, which are shorter than the Washington Accord standard and Engineers Australia and compliance for chartership.
- Uncertainty about the registration for Engineers and Design Practitoners and what documents have to be uploaded.
- Paul advised that we will take the issue back to the Government Committee that invites feedback of the issues – Paul sits in on the monthly meetings.

Joyce – raised a query about criteria for our membership. A particular application has experience but doesn't have chartership due to a quirk of the EA criteria. Andrew advised that the Articles give the Board discretion.

ACSE Board – response to communications from members, particularly sole traders, having issues with obtaining insurance renewals, specifically in relation to class 2 buildings. Les Millist noted that Planned Cover assisted him finding a new policy and they were very good.

John Butterworth raised a question about government assisted insurance scheme has been suggested. Mick commented that it has been acknowledge by David Chandler.

Paul identified the difficulties for small builders working on shop fit outs and renovations in getting registered. He also advised that the Government has waived the insurance requirement in the registration process in recognition of the difficulties obtaining insurance.
